L-1/132/2013/CERC dated 6th January 2014 and its subsequent amendments. The payment by the constituents for the billed amounts shall be made to the Regulatory Deviation Pool Account Fund operated by NERLDC within 10 days of the issue of this Deviation-Account. In case of delayed payments against these bills beyond 12 days, the defaulting constituent shall pay simple interest @0.04% for each day of delay.
