**79th Protection Co-ordination Sub-Committee Meeting (PCCM) & 226th Operation Coordination Sub-Committee Meeting (OCCM) -reg.**

महोदय/महोदया,

यह सूचित किया जाता है कि 79 वीं पी.सी.सी बैठक 19th मई, 2025 (सोमवार) को 11:00 बजे "एन.ई.आर.पी.सी कॉन्फ्रेंस हॉल", शिलांग में आयोजित की जाएगी। इसके अलावा, यह सूचित किया जाता है कि 226 वीं ओ.सी.सी बैठक 20th मई, 2025 (मंगलवार) को 10:30 बजे उसी स्थान पर आयोजित की जाएगी।

226 वीं ओ.सी.सी.एम के शटडाउन से संबंधित मदों पर ओसीसी बैठक से पहले 13th मई, 2025 (मंगलवार) तारीख को ऑनलाइन मोड में चर्चा की जाएगी (बैठक के लिए लिंक और समय ईमेल द्वारा अलग से साझा किया जाएगा)।


